1. **Proof of Income** (Pay stubs, Social Security Statements, Unemployment Statements, W2/1099 forms). Also, for cases involving divorce with children or legitimation, you must also provide a properly completed **Parenting Plan in addition to a Child Support Addendum with Child Support Worksheet or a current Child Support Order from Child Support Enforcement.**
2. **Final Order or Final Judgment and Decree** which as been properly prepared and completed with U.S.C.R. 36.4 compliance. This requires the signature of the "party who prepared the document with the preparer's name, proper address, and telephone number typed underneath."

The Clerk of this Court is directed to mail a filed copy of this Notice to all parties of record.
