2. In those cases involving child custody and/or child support, a properly completed **Parenting Plan, Child Support Addendum, Child Support Worksheet, Child Support Order from Child Support Enforcement and proof of income.**

Failure to appear on your scheduled court date and time may result in a dismissal of your case.
