Written announcements must be received in the judge's office by 10:00 a.m., July 22, 2024. Oral announcements and announcements by telephone will not be accepted. Email is the preferred method of delivery, but the announcement may be delivered by mail, e-mail, or hand delivery. Please choose only one method of delivery.

Failure to make a written announcement to the said judge as and when herein above provided, may, in the Court's discretion, subject the offending counsel or pro se party to the sanctions provided for in subsection (a) of U.S.C.R. 20.

Whether a case shall be placed on the pretrial calendar or trial calendar shall be solely within the discretion of the Court, regardless of what announcement is made (U.S.C.R. 8.1). No action will be continued merely by agreement of counsel (U.S.C.R. 8.5). If a case is not listed on this calendar, counsel or pro se party may contact my assistant, Brenda Owens, to request the addition of the case to the trial calendar.
