Whether a case shall be placed on the pretrial calendar or trial calendar shall be solely within the discretion of the court, regardless of what announcement is made (U.S.C.R. 8.1). No action will be continued merely by agreement of counsel (U.S.C.R. 8.5). If a case is not listed on this calendar, counsel or pro se party may contact my secretary, Becky Harrell, to request the addition of the case to the trial calendar.
